* **CITY COUNCIL SUCCESSFULLY PASSED A MORATORIUM OF 45 DAYS, DURING WHICH THEY WILL BE WRITING AN ORDINANCE RE: RESIDENTIAL CELL TOWERS**

WILL THEY WRITE A GOOD ORDINANCE?

Currently Pasadena is going through a similar process. According to our contact there, the proposed ordinance is even worse than the old law, so it's critical Glendale adopts a solid ordinance.

DOES T-MOBILE THINK THEY'VE 'LOST'?

Nope. They called 3 days after the decision, trying to set up a time to discuss their tower-siting process and talk about where else to put the tower. They have been quoted in the media as needing to address demand still.

WHAT CAN YOU DO?

(1) KEEP LAWN SIGNS UP. Any neighbor needing a lawn sign - more can be picked up outside of John McMahon's front door at 509 Cumberland Road, or from Marguerite at 1600 Pacific Ave.

(2) REVISED PETITIONING. We will be going door to door to get a SIGNATURE from EVERY neighborhood resident, tying that in to an assessor's map to show there is 0% support for this in the surrounding 2 block radius.

(3) CITY COUNCIL ELECTIONS ARE COMING in the first week of April. Ask candidates to take a position on this issue.

(4) EMAIL CITY COUNCIL AND CITY ATTORNEY. We have given them the **San Diego Ordinance** (available on our website). THIS IS THE GOLD STANDARD and already survived a legal challenge, which was won in the city/residents favor. All city staff has to do is COPY AND PASTE, but somehow Pasadena didn't do this, so we need to make sure the right thing happens here. EMAIL 'thanks' and 'encouragement' to ...
